Division of Agriculture honors Extension faculty, staff

Seven Cooperative Extension Service faculty and staff were among those recognized Jan. 12 during the University of Arkansas System Division of Agriculture and Bumpers College Agriculture Awards Luncheon at the new Don Tyson Center for Agricultural Sciences in Fayetteville.

Cecilia Harberson administrative support secretary and “go-to” everything for the Howard County Cooperative Extension Service, received the Division of Agriculture Classified Support Personnel Award.

Paul Beck, professor of animal science received the John W. White Outstanding Research Award for his work on forage and pastures. He joined the Division of Agriculture in 1997 as a herdsman while working on his Ph.D. He holds both research and extension appointments to the division and is now serving as interim director of the Southwest Research and Extension Center near Hope.

Tom Barber professor and extension weed scientist, received the John W. White Outstanding Extension State Faculty Award. Barber’s on-farm research on the control of PPO-resistant pigweed has helped more than 600 county agents, consultants, producers and industry personnel cope with the weed pest. He is frequently called on to provide expertise to the Arkansas State Plant Board and the media.

The Discovery Farm Team received the John W. White Outstanding Team Award. The team is led by **Mike Daniels** and Andrew Sharpley, both professors in the department of crop, soil and environmental sciences. Other

There's help available for tax filers

Tax filing season kicked off Jan. 29, 2018, and many tax filers find that they could use a little help. Here are some things that you might find useful as you prepare your tax return this year.

Guard against tax-related identity theft

Information on how to guard against tax-related identity theft (when a criminal uses someone else's Social Security number along with other personal data to file an income tax return, and reap any refunds, is available from the National Cyber Security Alliance (<https://staysafeonline.org>) and the Identity Theft Resource Center (<https://www.idtheftcenter.org>). A fact sheet offering tips for identifying cyber scams, actionable online safety steps and what to do if you fall victim to tax identity theft is available at <https://staysafeonline.org/wp-content/uploads/2018/02/Tax-Time-Tip-sheet-2018.pdf>.

Some helpful online IRS tools

The IRS has a few tools to help answer your tax questions. Taxpayers can access Publication 17, *Your Federal Income Tax* the *Interactive Tax Assistant* and *Where's My Refund?* on [IRS.gov](https://www.irs.gov).

Publication 17, Your Federal Income Tax

This publication covers the general rules for filing a federal income tax return. It explains the tax law to make sure someone pays only the tax they owe and no more. Using eBooks, taxpayers can view Publication 17 and other frequently used tax publications on their mobile devices such as smart phones, tablets and eReaders. IRS tax products are generally available online six to eight weeks before paper products are distributed. To view and download tax products, use the 'Forms and Pubs' tab on [IRS.gov](https://www.irs.gov).

Interactive Tax Assistant

The ITA provides answers to several tax law questions. The ITA includes a question-and-answer session for a variety of topics. Users simply respond to basic questions to find the answers they need.

Where's My Refund?

Taxpayers can use this tool on [IRS.gov](https://www.irs.gov) or with the IRS2Go mobile app for a personalized refund status. Taxpayers can generally check the status of their refund 24 hours after the IRS receives their e-filed return.

Tax time money-saving tips

Here are some ways to save money on your taxes from Laura Hendrix, associate professor – Family and Consumer Economics, Accredited Financial Counselor.


Tax preparation: Paid tax preparation costs an average of \$300. If using a paid service make sure it is reputable. For complicated returns, a paid tax preparation service or accountant may be the best option.

Most consumers can use a low-cost or no-cost option. If your taxes are straightforward you may want to file your taxes online with MyFreeTaxes. **If your household earned less than \$66,000 in 2017, you can file both your federal and state returns for free using [MyFreeTaxes.com](https://www.myfreetaxes.com).** This is the only free, national, online tax filing product offered by a non-profit the United Way.

If you would rather have someone help you prepare your taxes, visit the [IRS website](https://www.irs.gov) to find your closest free tax preparation site. Free tax volunteers are trained and certified each year by the IRS to ensure accuracy.

Tax Credits: Tax credits can lower the amount you pay or increase your refund. The Earned Income Tax Credit (EITC), in particular, is an important credit to look out for. Many families who qualify for the EITC can also claim the Child Tax Credit. If you or your child are in college you may qualify for The American Opportunity Tax Credit or the Lifetime Learning Credit.

Save Your Refund: Plan now to use your refund wisely. Use Form 8888 to have your refund deposited directly into your bank account. You can designate up to three accounts; so part of your refund can go into your checking account and part can go into your savings account. If you have high interest debts, paying those debts first helps avoid losing money to interest payments. Additional money can be saved for an emergency fund in a savings account or put into retirement.

Marvin Wall, retired Extension entomologist, dies

Marvin Leslie Wall passed away at the age of 77 on Jan. 30 after a sudden illness. Graveside funeral services were held Friday Feb. 2, at the Tillar Cemetery in Tillar, Arkansas.

Marvin attended the University of Arkansas, Fayetteville where he received an M.S. degree in entomology. After college he served as an assistant county agent in Lincoln County. Marvin left Extension and served as a navy lieutenant in the Vietnam War. After serving his country he returned to Extension in 1969 as the Southeast Arkansas entomologist until his retirement in 1995.

Marvin was a hard-working entomologist and one of the most knowledgeable people I have ever worked with in my career. At a recent meeting where he was recognized by the Arkansas Crop Protection Association for his outstanding achievements in serving Arkansas agriculture, I was honored to be able to give him his award. When I handed him his award he told the audience that although he had tried to teach me all he could, I still didn't know anything!

Marvin was "bigger than life" and was the living embodiment of the Land Grant Mission, serving the growers and county agents in southeast Arkansas. He was the quintessential Extension entomologist and one of the best people I have ever worked with in the field. While he will be missed, he won't be forgotten, and his legacy of service to the growers and agriculture in Arkansas will live on through those of us he touched in his life.

Marvin was a member of the McGehee Church of Christ. He is survived by his wife of 54 years, Frances Wall; two children, Leslie Pierce and Steven Wall; and four grandchildren.

Marvin passed at the end of January, but I was lucky enough to see him again last fall at the retiree luncheon in McGehee. As was usual in our relationship Marvin gave me good advice this time about what I should think about in being a "good" director if there was such a thing. I worked with him a number of times on trying to figure out "odd" things that he noticed on cotton, soybeans, pecans and vegetables in the southeast part of the state and often his observational and reasoning skills were better than mine – but I at least had the opportunity to learn from the best.

Noal Lawhon passed forward last week, and I was fortunate enough to attend his visitation. Noal and I went back to about 1980, and he taught me a tremendous amount about dealing with people in an ethical and friendly manner. Noal was a major player in ag business over the years and volunteered for many thankless jobs supporting the industry in this state and the country. He was a role model of respect and sincerity to others, and he was so very proud of his family. At the crowded visitation, I saw many old friends from the ag industry and heard so many testimonies of the character that Noal lived every day. It is easy to talk ethics and morals, but Noal actually lived his.


Dennis Gillam, the founder of Gillam Farms near Judsonia, also passed forward last week. He was a great friend and a supporter of thousands of people and organizations. Dennis would do anything for anybody give you the shirt off his back and never say anything to anyone about it. He was a remarkable person.
